CONTEST OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. PURCHASING PRODUCTS OR SERVICES FROM CALIFORNIA COAST CREDIT UNION WILL NOT IMPROVE YOUR CHANCES OF WINNING. EACH ENTRY HAS AN EQUAL CHANCE OF WINNING. The “Guess the Tees Concert and Zoo Ticket Giveaway” (Contest) begins 9:00 AM Pacific Daylight Time (PDT) on July 20, 2021 and ends 5:00 PM PDT on August 06, 2021 (Contest Period). By entering this Contest, entrants accept and agree to be bound by these Official Rules. Contest void where prohibited by law. California Coast Credit Union (California Coast) is the sponsor of this Contest (Sponsor). This promotion is in no way sponsored, endorsed, or administered by or associated with Facebook, Twitter or Instagram.

WHO MAY ENTER: Entrants must be at least 18 years of age, have valid government issued identification and valid tax identification number. California Coast employees, officials, and members of their immediate families are not eligible to participate in the Contest. Business entities are not eligible to participate. Contest is void in Puerto Rico, U.S. territories and possessions outside of the United States, and where restricted or prohibited by law.

HOW TO ENTER: Eligible entrants must complete the form found at <https://www.calcoastcu.org/guessstheees> to guess the total number of golf tees in the display bowl at a Cal Coast Branch. Eligible entrants may enter this Contest via Online or Mail. The entry methods are described below. LIMIT: UP TO ONE (1) ENTRY PER PERSON PER CONTEST PERIOD REGARDLESS OF METHOD OF ENTRY. All entries must be received by 5:00 PM PST, August 6, 2021. Multiple entries received from any person beyond this limit will void all such additional entries. **Online Entry Method:** Entrants must complete the form found at <https://www.calcoastcu.org/guessstheees>. **Alternative Method of Entry (AMOE):** Mail a 3” x 5” card with your guess of the total number of golf tees in the bowl, your first name, last name, home branch, complete address, city, state, zip code, home phone number (including area code) and email address (if any) to “Guess the Tees Concert and Zoo Ticket Giveaway” c/o California Coast Credit Union, Attn: Marketing Dept., PO Box 502080, San Diego, CA 92150-2080. California Coast will not verify receipt of entries for entrants. All entries submitted become the sole property of California Coast and will not be returned. Sponsor is not responsible for lost, late, misdirected, illegible, or damaged AMOE entries. All AMOE entries must be received by 5:00 PM PST, August 6, 2021 to qualify.

Prize/Approximate Retail Value: First place winner will receive their choice of either two (2) John Legend concert tickets or four (4) San Diego Zoo tickets. Second place winner will receive the remaining prize. The Approximate Retail Value (the “ARV”) of the two (2) John Legend concert tickets is \$258. The ARV of the four (4) San Diego Zoo tickets is \$248. Odds of winning are based upon the number of entries. Based upon California Coast’s estimate of 250 entries, the odds of winning any prize are 1 chance in 250. Prize is not transferrable.

Selection of Winners: Two (2) winners will be chosen on August 6, 2021. The entry with the guess closest to the total number of golf tees, without going over the actual number in the display bowl at a Cal Coast Branch will be selected as the first place winner and will receive their choice of either two (2) John Legend concert tickets or four (4) San Diego Zoo tickets. The entry with the next guess closest to the total number of golf tees without going over the actual number in the display bowl at a Cal Coast Branch will be selected as the second place winner and will receive the remaining prize. In the event of a tie for first or second place, a random drawing will be held for the winners who tied and a winner will be selected. A panel of representatives from the Sponsor will judge the entries and resolve any disputes that may arise during the contest. All decisions by the panel are final. The winner will be contacted via email or by phone call. If Sponsor is unable to contact the prospective Winner within 24 hours of being contacted, or if the prospective Winner does not meet eligibility qualifications, his/her prize will be forfeited and an alternate prospective Winner shall be selected. The prize will be sent via email.
